PSYCHE BIDS

A psyche, or psychic bid is defined as "A deliberate and gross misstatement of honour strength and/or of suit length." There are two important parts of this definition to remember: "deliberate" – a mistake is not a psyche; "gross" -- a small variation (e.g. Opening 1NT with an 11 count, or a weak 2 bid on a five card suit) is not a psyche. Psyches are legal so long as they do not become part of your partnership's understandings. For instance, if you observe that your partner will never pass in third seat non-vulnerable after two passes, then you are in a better position to deal with his psychic openings there -- so they are not psyches at all, and must be disclosed as part of your "system" to the opponents (e.g. by alerting all of partner's opening bids in this position.) Similarly, if your partner always opens balanced 11 counts with 1NT, then you are playing an 11-14 NT range and not a 12-14 range, and must note this on your convention card.

Since the early days of contract bridge players have debated the ethics and effectiveness of psychic bidding. No consensus has ever been, or is ever likely to be reached. It's relatively widely considered to be impolite to psyche against opponents who (in your opinion) are much weaker than you. Frequent psyching (more than once per session) is so likely to create partnership understandings that it is very strongly discouraged. In part to monitor this, psychic bids are supposed to be recorded and registered with the director during, or immediately after, the session in which they are made (forms to do this are available in both the Cargill and Larnach rooms). The responsibility for recording a psyche rests with the player who made it, though in order to ensure compliance it's not inappropriate for the other partnership to mention to the director that a psyche occurred and who made it. The director can then follow up if no report is received.

Dealing with psyches is difficult. It's natural to feel somehow swindled when a psyche succeeds. Under those circumstances, it's important to remember that generally nothing illegal or unethical has occurred (unless you are concerned that the psycher's partner has "fielded' the psyche, e.g. by failing to raise partner's opening bid when holding significant support). If you do wonder if there is an issue of legality, then, as always, the correct approach is to politely call the director, calmly explain your concerns, allow the opponents to state their position, and listen to the director's decision.
