MESSAGE FROM YOUR PRESIDENT

We are pleased to report to Members that the Club is now the owner of the land on which the club rooms are situated. All the required payments have been made and the final transactions were completed over the past week, with the actual transfer happening on Wednesday March 29. Sources of funds towards the total cost of \$651,500 have been:

- \$364,000 in loans from Members
- \$70,000 as a grant from the Otago Community Trust
- \$66,867 in Member donations
- \$150,633 from cash reserves

Because no bank funding has been needed, the Club is still mortgage-free but the Member loans are to be repaid over the next 15 years and will require the Club to continue to operate with a strong membership base and activity level. We appreciate the sacrifices Members have made through their contributions that will help secure the Otago Bridge Club's future with its own premises on its own land. We would still appreciate any donations towards the project that would help reduce the interest costs to be paid, so please advise any committee member if you could contribute in this way.

The land purchase has been a major undertaking that has involved many people over a long period of time. This current negotiation started in November 2015 but there have been previous attempts

over the years that haven't succeeded. Thank you to all Members who have contributed in some way to reach this point, which is another milestone in the Cub's history.

LAWS OF BRIDGE UNINTENDED CALL, LOSS OF CONCENTRATION

If you have a lovely heart opening hand with a void in spades you sometimes find to your horror that you have written down 1S. Call the director, this is obviously an *unintended* call and you will be allowed to change it as long as your partner has not yet spoken. Sometimes you only realise you have written down the wrong thing when LHO asks a question or partner alerts your bid. You will still be allowed to change. But if you make the wrong call because you have not been paying attention or have lost concentration you will not be allowed to change. Eg: 1H - 1S -2S-P -P! You carelessly thought that your partner was giving you a minimum raise and did not notice that it was a cue bid. Too bad – you should have been paying attention . This is laid out quite clearly in the 2017 laws – up to now I would have ruled this to be inadvertent.

LAWS OF BRIDGE INSUFFICIENT BID

When you make an insufficient bid LHO opponent may choose to accept the bid after hearing all the options which are open to you. If you correct the insufficient bid with the lowest call specifying the same denomination as the insufficient bid, everything goes on as usual - even if the bid is quite different! Eg 1S IH - you may correct to 2H but also 1NT - 2S - 2D (transfer) may be corrected to 3H as this is what the 2D bid showed. This is now known as a *comparable call*.

Similarly you may correct the insufficient bid with another bid if it has the same or a more specific meaning eg 1C 1S *IH* may be corrected to 1C 1S *X* if you play that a negative double guarantees the other major. And if you reply to a 4NT Ace ask with 4H you will be allowed to correct to either 5H if you intended to show 2 Aces or 5D if you intended to show one. The director will frequently have to ask you to leave the table to discuss the intention of your insufficient bid, and will be able to advise you on what bids, if any, you may make without penalty.

If there is no available comparable bid you can make, and you do not necessarily want to make your bid sufficient (now that you have realised it is at a higher level) or you think perhaps with the opposition bidding you might be wiser to jump to game you may do anything you like – pass, bid a completely different suit, jump to game or slam– *but* your partner will now be debarred from the auction. LHO must decide, after hearing the options open to you, but not your actual decision, whether or not to accept the insufficient bid.

Should you accept an insufficient bid? Not usually if you and your partner are not in the auction. But if you are interested in bidding it may be to your advantage to accept the bid if you can now bid at a lower level. 1D 1S 1H – if you accept this you can bid 1S to show support for your partner but

not many points, or 2S jumping to suggest game but still being at the two level! And if you do not accept the bid the offender may choose to jump to game – his/her partner will not be able to speak again but it might now be difficult for you too.

LAWS OF BRIDGE BIDS AND CALLS OUT OF ROTATION

The rules vary here depending on whether it is a pass or a bid, and on whose turn it really was to

speak when the call out of rotation was made. The director will explain the applicable rules which have now been simplified. The next opponent to speak may always accept the call but if not - if you pass at RHO's turn to speak you just repeat the pass on your next turn.

If you pass at LHO or partner's turn, if you have not previously spoken, partner may make any legal call and so may you, as long as the meaning is comparable, eg if partner opens a game force, you may make a negative or a relay response as this is comparable to your (presumably) 0-10ish point initial pass.

Similarly, if you make a bid out of rotation, if it is not accepted, if it is at RHO's turn to call, if you can repeat the same call, or if you can make a comparable call, all goes on as usual. If you cannot make a comparable call, partner must pass when next it his turn to call (but if the auction continues, may speak after that).

If the call out of rotation is at LHO or partners turn, if you have not previously called, partner may make any legal call as may you. If your call is however not comparable to the call you made out of rotation, partner must then pass at his *next* turn. You will not usually be able to double but there are some occasions when this would be a comparable bid.

If you cannot make a comparable call you may decide to jump to a game because your partner will have to pass next time. Realising that offender may make a jump to game will help opponents decide whether or not to accept the call out of rotation. Since the bidding will revert to the correct player if it is not accepted the non-offending side will get at least one call in first.

LAWS OF BRIDGE BIDDING PADS AND EXPLANATION OF CALLS

Not every country uses bidding pads, most use bidding boxes. Once upon a time bidding was spoken, and many will remember the forceful double from someone who is doubling for penalty rather than take out, or the 4C on a rising intonation when it is an ace ask not a suit! NZBridge lays down the rules for the use of bidding pads, but these are based on the actual rules of bidding. For example, Law21 allows for changes of call based on misinformation, and NZBridge says that illegible handwriting is misinformation. Certainly a bid seen from the side or upside down often looks different if written carelessly.

Laws 20 and 41 talk about reviewing calls. During the auction you may ask the meaning of a call at

your turn to speak, or when the auction has ended and the opening lead has been made but not turned over, or throughout the play at your turn to play. Players should give a full explanation but if they do not seem to be doing so or use terms you do not understand. call the director for help.

If you are not intending to enter the auction you should not ask about the bidding during the auction. If your opponents are playing a very artificial system with lots of alerts it is often wise to wait until the auction is over and then ask each in turn what partner has shown.

You are entitled to have all calls restated during the auction—but with bidding pads there they are. This option ceases when the auction has ended and after each person's first turn to play. Declarer's first turn to play is when playing from dummy. When the opening leader's partner has played the bidding pad must be turned over as a full review of the auction is no longer permitted. You may still ask what the contract is and whether or not it is doubled at your turn to play—just not have a full review.
