#### **REVOKES**

In a previous article on Revokes the statement was made that although Dummy can revoke there is no penalty or (more correctly) rectification. This is strictly true (Law 64 B3), but it may have given the impression that no correction can take place. Law 64C gives the Director the power to award an adjusted score if the non-offending side is insufficiently compensated by the automatic rectification from Law 64. This power is available after any established revoke, including those not subject to rectification listed in Law 63B.

# SEVEN THINGS TO KEEP THE DIRECTOR HAPPY

- When you call the Director, try not to use an impatient or exasperated tone. "Director please!"
  is nice. It is also important in calling the Director not to demean or upset the person who has
  committed the infraction. Everyone bids out of turn or revokes or leads out of turn once in a
  while.
- 2. When the Director arrives explain clearly and briefly what has happened. It is best if the caller or the perpetrator does this: nothing worse than four people talking at once.
- 3. Listen to the Director's ruling: often you have alternative actions to choose from.
- 4. Make sure you know a bit about the rules. You really only need a rough idea of the basics on
  - Insufficient Bid (Law 27, changed in 2007),
  - Bid out of Turn (Laws 29-32).
  - Penalty Card (Laws 50-52),
  - Lead out of Turn (Laws 53-56) and
  - Revokes (Laws 61-64).

If you have no idea of the Rules things can get very confusing.

- 5. Think about your options, if any. It may annoy opponents if you always make them retract their lead or their insufficient bid, but often it is worth considering whether to accept it.
- 6. If you do not agree with the Director's ruling, or feel that you have been insufficiently compensated for the infraction, inform the Director as soon as you can, preferably at the end of play on that board. That way an appeal, if necessary, can be heard in good time, perhaps in the supper break. If you decide after the last board that you wish to appeal a prior ruling it is a bit late; in a tournament that would be acceptable as there is time between sessions, but not in Club play.
- 7. Remember Bridge is a Game and try to retain a sense of proportion as well as a sense of humour.
